## RESOLUTION TO GRANT A REGISTERED ORGANIZATION ADULT-USE CULTIVATOR, PROCESSOR AND DISTRIBUTOR LICENSE OR A REGISTERED ORGANIZATION ADULT-USE CULTIVATOR PROCESSOR DISTRIBUTOR RETAIL DISPENSARY LICENSE TO CERTAIN REGISTERED ORGANIZATIONS.

**WHEREAS**, pursuant to Section 10(1) of the Cannabis Law, the Cannabis Control Board (Board) has the authority to issue any registration, license or permit;

**WHEREAS**, pursuant to Article 4 of the Cannabis Law (Article 4), a registered organization registered by Article 3 of the Cannabis Law that applies for a registered organization adult-use cultivator, processor and distributor (ROND) license or a registered organization adult-use cultivator processor distributor retail dispensary (ROD) license must provide certain information to the Board prior to license approval;

**WHEREAS**, pursuant to Section 120.7(a)(2) of Title 9 of the New York Codes, Rules and Regulations (9 NYCRR), in order to be granted a ROND or a ROD license, a registered organization must meet certain criteria and submit certain information through the submission of an application with the Office of Cannabis Management (Office) for subsequent approval or denial by the Board;

**WHEREAS**, pursuant to 9 NYCRR 120.7(d), an applicant must submit the required license fee pursuant to 9 NYCRR 120.4 upon Board approval and prior to licensure;

**WHEREAS**, certain registered organizations have completed such application to transition to a ROND or a ROD license to the satisfaction of the Office;

**WHEREAS**, pursuant to Section 10(1) of the Cannabis Law, the Chairperson of the Board has made a preliminary determination to grant a ROND or a ROD license to certain registered organizations that have applied for the transition of its registration to an Article 4 license through the aforementioned application process, subject to payment of required license fees pursuant to 9 NYCRR 120.4;

**WHEREAS**, the members of the Board waive their right pursuant to Section 10(1) of the Cannabis Law to take up to 14 days from the Chairperson’s preliminary determination to object to the Chairperson’s preliminary determination or to request that the matter be brought before the full Board for consideration;

**WHEREAS**, no member of the Board objects to the Chairperson’s preliminary determination to grant a ROND or a ROD license to certain registered organizations that have applied for the transition of its registration to an Article 4 license through the aforementioned application process;

**RESOLVED**, that the Board grants a ROND or a ROD license to every applicant that received the Chairperson’s aforementioned preliminary determination to grant a ROND or a ROD license, subject to payment of required license fees pursuant to 9 NYCRR 120.4.

**BE IT FURTHER RESOLVED**, that upon payment of all required ROD fees, a registered organization who was previously approved as ROND, can transition to ROD license upon submission of the required licensing fees and any other requirements for the ROD license as determined by the Office and set out in 9 NYCRR.
